Fox Sales. Mr. Fox was a dedicated leader in the industry and served on the WSWA Board of Directors for 20 years including his 2015-2016 term as Chairman.

Beyond his work on the Board, Mr. Fox was an active member of the association including serving as the Chair of the WSWA Council for Leadership Development and the Meetings & Convention Committee, as well as Vice Chairman of the WSWA Finance & Audit Committee. Mr. Fox served on the WSWA Small Enterprise and Government Affairs Councils until his death.

"Brien's industry leadership, business insight, and deep understanding of the beverage alcohol ecosystem made a lasting impression on his peers and our association. We at WSWA will miss him especially after his years of enthusiastic participation at every level of our governance. He will be profoundly missed by our WSWA team and membership.
