All members in the Association shall support the principles and	<ul> <li>(From Article III, Sections 1 and 2.)</li> <li>Members: Any duly licensed person, firm or corporation that: <ul> <li>a) Holds a basic permit under the Federal Alcohol Administration Act as a wholesaler; and,</li> <li>b) Holds an appropriate state license and/or permit as a wholesaler; and,</li> <li>c) Is engaged in the business as a wholesaler of distilled spirits and/or wine and has been so engaged for at least one (1) continuous year; and,</li> <li>d) Purchases distilled spirits and/or wine from the primary sources of supply for resale at wholesale to retailers within the state</li> </ul> </li> </ul>
